### SECTION 6 – ACCIDENTAL RELEASE MEASURES

<b>Personal Precautions, protective equipment, and emergency procedures</b>	In case of rupture. Attention! Corrosive material. Avoid contact with skin, eyes and clothing. Ensure adequate ventilation. <b>Other Precautions</b>	In case of rupture. Handle in accordance with good industrial hygiene and safety practice. Avoid contact with skin, eyes or clothing. Use personal protection equipment.
